United States v. Scott Bessent HA-24-8-26

Scott Bessent is warranted to be arrested and brought to Court to stand trial for six counts of restraint of trade, for which the sentence is up to ten years in prison, for Donald Trump to bail out for \$600 million fine and a new Treasury Secretary who is not an intellectually disabled sexual offender. Tariffs must not increase pursuant to *Learning Resources, Inc. v. Trump* 607 US (2026). (a) Last check the Maryland District Attorney email was blocked and the District of Columbia was expensively blocking online licenses. Service of the Actuary is sought. As Treasury Secretary, Scott Bessent has proven beyond a shadow of a doubt that homosexuals are intellectually disabled sexual offenders to be registered by the Court on a criminal case by case basis. In this case the debtor needs to be arrested for restraint of trade and sentenced to up to 10 years in prison under 15USC§1 et seq. more than five years for treason under 18USC§2381 to heighten scrutiny of Sec. 20,000(c) of An Act Supplementing appropriations for the fiscal years ending Oct. 1, 2017-27 [HA-30-7-26](#).

(b) Because the United States cannot pay their Treasurer's bail, and his crimes do not leave his adopted child a middle-class wage, President Donald J. Trump Jr. is sought to bail out his insubordinate homosexual partner in false statements to justify war crime 18USC§2388 for no less than six counts of \$100 million fine for restraint of trade, more than \$600 million plus \$5.8 million for E. Jean Carol, flat chested Epstein hooker like Melania and Pam Bondi, from his excessive private compensation? 11USC§723.

(1) Trump should know better than to attack Iran in contempt of the tariff increase ban in *Learning Resources, Inc. v. Trump* 607 US __ (2026) to mark the conjunction of Neptune and Saturn at zero degrees Aries on February 20, 2026 and end of his immunity for his unofficial war crimes, tariffs and refouler officiated in *Trump v. United States* 603 US __ (2024). Trump's responsibility for 10,000 murders a year has shifted from involuntary manslaughter by deportees to voluntary s-nuke earthquakes and conventional murder or manslaughter of foreign officials, official guests and internationally protected persons under 18USC§1116.

(2) It seems urgently advisable to oppose the discharge of the debtor under 11USC§704(a)(6). Debtor is defined by the news media to the tune of \$40 trillion as being too intellectually disabled to calculate outstanding debt of less than \$14,294 billion pursuant to Sec. 20 of An Act Supplementing appropriations for the fiscal years ending Oct. 1, 2017-27 [HA-30-7-26](#). Will election criminals Bush and Trump die in prison while Haiti s-nuking ballot stuffing Biden walks off the stud ranch pursuant to 52USC§10307 and What USA Has No-Vote in the Assembly Means to the 2026 Midterm Elections [HA-17-8-26](#).

(3) The Court is unable to grant the debtor a discharge because the debtor is not an individual, he is an intellectually disabled sexual offender like Trump, who grew up in New York City in the shadow of the Court of International Trade of the United States (COITUS) and Title 22 of the United States Code Foreign Relations and Intercourse (a-FraI-d) and started a fraudulent war with Iran when granted the power and duty of the President's Budget: An Act To change the name of the Department of Homeland Security (DHS) to United States Customs (USC), Court of International Trade of the United States (COITUS) to Customs Court (CC), and amend Title 22

of the United States Code Foreign Relations and Intercourse (a-FRaI-d) to Foreign Relations (FR-ee) [HA-2-2-26](#).

(4) The intellectually disabled, sexually offending debtor, has failed to keep or preserve the Treasury Budget Request for IRS Discretionary Appropriations only, Interest Payments, Mandatory accounts, or Tax-Direct spending, not to mention COVID termination in violation of 11USC§727(a)(3). The Treasurer is not only held in Trust, for the 75 percent of the Treasury budget he is not smart enough to account for, but he is keeps squealing like a Bay of Pigs regarding sanctions and tariffs in contempt of Court, Congress and especially the Trustee who produced Part 416 Department of the Treasury of the President's Budget) [HA-2-2-26](#).

(5) Bessent and Trump must cease to increase tariffs in contempt of *Learning Resources, Inc. v. Trump* 607 US (2026) and *V.O.S. Selections, Inc. v. Trump* No. 25-00066 and *State of Oregon v. Trump* No. 2500077 of May 28, 2025. Customs revenues are overestimated by Customs and Border Protection and the Office of Management and Budget and now the US not only has to pay \$5,200 (2026) UN Compensation to the state receiving every deportee but must refund unlawfully taken customs overestimates 18USC§1033. Actual customs revenue numbers are believed from the fees reported at the top of the Homeland Security budget. Increasing tariffs is not a money, and has never been a money maker. Increasing the price of tariffs causes retaliatory tariffs and reduces the supply of goods due to the price elasticity of demand. Imports are not a fine art or real estate whose value goes up with a corrupt asking price, tariffs go up, volume goes down, net-zero or less due to offended friends.

(6) The final lesson is that sanctions against Venezuela, Iran, Cuba etc. are especially vicious because they are completely false allegations in piratic restraint of trade. Iran Sanctions, Accountability, and Divestment Act of 2010 22USC§8501-8551 must be repealed because the Fukushima Biden produced a false statement 18USC§2388 and Venezuela, Iran, Cuba etc. must be repealed from 31CFR§500 et seq, and the rest carefully edited to repeal restraint of trade under 15USC§1 et seq pursuant to *United States v. Nicolas and Cilia Maduro*. Customs Court. Hospitals & Asylums HA-3-1-26, [HA-6-1-26](#) In re: Certain Iranian Assets (*Islamic Republic of Iran v. United States of America*); \$80 billion Unlawful Sanction Theft Bond effective Oct. 1, 2026 [HA-15-7-26](#). Stolen Venezuelan oil filled railcars are causing oceanic warming off the coast of Ecuador, called El Nino, affecting the Pacific Coast and in the Mediterranean, and need to be extinguished with, removed from the ocean and quickly brought to a refinery pursuant to Permanent Sovereignty over Natural Resources and Sec. 30,000 of An Act Supplementing appropriations for the fiscal years ending Oct. 1, 2017-27 [HA-30-7-26](#). Executive Order 13871—Imposing Sanctions With Respect to the Iron, Steel, Aluminum, and Copper Sectors of Iran is a textbook \$100 million fine for restraint of trade 15USC§1 et seq.

(c) Whereas the debtor has refused, in the case, to obey any lawful order of the court, to not increase tariffs in *Learning Resources, Inc. v. Trump* 607 US __ (2026) and the President thinks this insubordination is sexy under 11USC§704(6)(A) because he believes fraud does not cause calculus of the arteries, like real business math, no matter how much restitution for making war under false pretense of 22USC§8501-8551 to be repealed pursuant to Alleged violations of the 1955 Treaty of Amity, Economic Relations, and Consular Rights (*Islamic Republic of Iran v. United States of America*) No. 175 3 October 2018 and Certain Iranian Assets (*Islamic Republic of Iran v. United States of America*) Judgment of 30 March 2023. In conclusion, the President

owes the Court \$600 million to bail out his intellectually disabled sexual offender Scott Bessent who is disqualified to hold office of Treasurer under 18USC§2071.

(d) Furthermore, to clean up the entire federal financial crime: Russell Vought, committed treason begging for the Iran War, to avoid responsibility for the President's budget, because he is not competent to stand trial for fraud, and must be removed from office, arrested by the Secret Service and brought to trial in the United States District Court for the District of Columbia for his fraudulent and downright terrorist bankruptcy entries and statements 18USC§1001, advocacy of overthrow of government 18USC§2385 and terminally, false statements affecting armed forces in times of war 18USC§2388, Iran war crime 18USC§2441, assassinating the Ayatollah Khomeini and at least one elementary school of children 18USC§1116, due to his treason 18USC§2381. Vought's war funds that he corrupted the President with to make war with Iran must be seized by the US District Court for the District of Columbia. In FY 27 funds for \$146,147 thousand FY 26 plus 3 percent inflation to +/- \$150,531 thousand for the Office of Management and Budget (OMB) must be terminated due to treason 18USC§2381. OMB staff, other than Vought, who must be removed from office for treason, shall be paid salary, not to exceed \$3 million, to continue accounting for the federal government, although totally failed, since misled by BFS in 2020. Bureau of the Fiscal Service (BFS) funding must also be terminated because they cause industrial explosions, every email, lethal since 2025, to avoid trial for their fraud \$448.3 million FY 26, plus 3 percent inflation to \$461.8 million FY 27, leaving Fiscal Service, Salaries and Expenses: \$3 million to de-bug. IRS Statistics must do their own accounting and must discharge the powers and duties of the terrorist Bureau of Fiscal Service and Office of Management and Budget (BOMB) pursuant to the 25th Amendment of the US Constitution and 11USC§727.
